Are photovoltaic solar energy systems safe?

The safe and reliable installation of photovoltaic (PV) solar energy systems and their integration with the nation's electric grid requires timely development of the foundational codes and standards governing solar deployment.

Will EPA add photovoltaic solar panels to the Universal Waste Management Program?
