Why do emergency responders need in-building Erces?

When emergency responders enter a building their ability to maintain interoperable and continuous communications is paramount to the protection of both public safety and the public's safety. An In-Building ERCES ensures that communication signals can penetrate into all areas of buildings in accordance with model fire codes and standards.

Do emergency traffic messages have priority over other radio communications?

In a critical situation, emergency traffic has priority over all other radio communications (with the exception of "mayday" message). All other radio traffic must cease and personnel must monitor the emergency traffic message. After receipt of an "emergency traffic" message, it should be repeated on all appropriate channels.

Why do emergency responders need in-building wireless communications?

The need for in-building wireless communications for Emergency Responders resulted in the development of national model codes by the National Fire Protection Association (NFPA) and the International Code Council (ICC) as early as 2009.

All EMS providers/agencies involved must complete a patient care report for each patient contact or request for response (e.g. agency is cancelled enroute to a call then a "cancelled call" chart must be ...

Call back number/frequency: "Before terminating communications with medical control, prehospital personnel must notify medical control of a method by which the ambulance can be re-contacted, and ...

Voice orders to EMS personnel via radio, telemetry, or cellular phones shall be given by or under the direction of the EMS System Medical Director (EMS MD) or designee, who shall be either an ...

After receipt of a "mayday, mayday, mayday" message, Command will initiate (request through BC or IC or personally signal) the RIT team and repeat the message on the tactical channel.
