Can a provider sell a photovoltaic system to a customer?

Who is responsible for obtaining a solar system approval?

NOTICE: You are solely responsible for obtaining at Your sole cost and expense, at least thirty (30) days prior to installation of the Solar System, any approvals to install the Solar System that may be required by any HOA to which the Property is subject.
